RANGE SAFETY RULES

Safety is our number one concern and priority. We firmly believe that it is everyone's responsibility to assure that the entire range area is safe at all times!

The Range Safety Officers are present for your safety. You will follow their instructions at all times.

There will be no loaded firearms or magazines allowed at any time unless a command to load is given by the Instructor.

An Instructor or Range Safety Officer (RSO) will meet you when you arrive at the range.

If you arrive at the range with a loaded firearm, you will notify the Instructor/RSO that you have a loaded firearm. The Instructor/RSO will take you down range to clear the firearm, lock the slide open (semi-automatic) and empty the magazine. If equipped with a safety, it will remain on until instructed to release it.

All firearms will be kept in the range bag or transport case, placed on the table pointing down range until other instructions are given.

You will then report to the trailer where you will complete all the necessary paperwork.

Following that, there will be a review of Article 35 of the NYS Penal Code and an examination that is required by the NYS Division of Criminal Justice Services.

Once instructed to retrieve your firearm, it will remain holstered with the slide open (semi-automatic) and the magazine well empty.

Protective hearing and eye protection and a hat with a brim will be worn at all times.

If anyone sees or experiences something that is unsafe or you feel threatened, you are to immediately yell "FREEZE" and wait for the Instructor/RSO to assist you.

If the word "FREEZE" is yelled, you will immediately stop whatever you are doing and re-holster your firearm and wait for further instructions.
